**VIOLATION NOTICE**

On May 14, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Magna Mirrors Corporation located at 3575 128<sup>th</sup> Avenue, Holland, Michigan. The purpose of this inspection was to determine Magna Mirrors Corporation's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) numbers 188-04G and 184-19.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Burn-off Oven	PTI 184-19, SC IV.4 and VI.1	Failure to continuously record the temperature of the secondary combustion chamber.

Magna Mirrors Corporation failed to continuously record the secondary chamber's combustion temperature for the burn-off oven, which is a violation of SC IV.4 and VI.1 of General PTI number 184-19.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by July 23, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.


