FACILITY BACKGROUND

Advanced Technology & Testing ATW (Advanced Tech) manufactured the testing units for transmission on the automobile assembly lines. Advanced Tech was permitted for a paint booth for coating engine test stands. The paint booth had exhaust filters and vented to a stack on the northwest side of the building.

COMPLAINT/COMPLIANCE HISTORY

No complaints have been received regarding this facility. No Letters of Violation (LOVs) have been received regarding this facility since the last inspection.

PROCESS EQUIPMENT AND CONTROLS

This facility manufactured test stands for the automotive industry. The stands were painted at a different facility, but touch-up painting and the painting of smaller parts was painted on an as needed basis. There was no cure oven associated with the paint booth. Welding and grinding also occurred at this location.

INSPECTION NARRATIVE

I arrived at the facility at 8:15 am. I entered the parking lot, and there were no vehicles present in the parking lot. There were no flags present on the flagpole. Also all Advanced Tech signs have been removed from this location, and there is a "For Lease" sign present on the property. The front door was locked and the lights were off. A sign on the door said that the facility has moved to 1 ATS Drive Wixom, Michigan 48393.

APPLICABLE RULES/PERMIT CONDITIONS

Advanced Tech was operating a paint booth at this location under Permit To Install 61-92 for a paint booth. The facility is no longer operating at this location; it is assumed that the equipment has been removed. Therefore the permit should be voided.


