On October 14, 2015, I conducted a level-2 **scheduled** inspection of Joslyn Fuels, Inc. , Marathon Gas Station # 123661 ("Joslyn Fuels") located at 23426 Industrial Park Court, Farmington Hills, Michigan 48335-2848. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994, PA 451 and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

During the inspection, Mr. Raj Anghan, (Phone / Cell: 734-330-1028; Fax: 248-404-6911; E-mail: rAnghan@Hotmail.com), President and Owner, assisted me.

Atlas Oil acquired the property from Clark Oil. One of them was perhaps responsible for the remediation. Marathon bought Atlas Oil. Mr. Raj Anghan bought from Marathon Oil the gas station and kept the brand name.

Mr. Raj Anghan operates the gas station and the store under Joslyn Fuels, Inc. Joslyn Real Estate, LLC. owns the property such as land, building. Mr. Raj Anghan owns them both.

I walked around the gas station store building, surveyed and determined that there was no soil / groundwater remediation activity. There was no remediation trailer.

Per MDEQ-RD databases, most recent activity was in 2012.

Conclusion

There is no soil / groundwater remediation activity. GPTI No. 330-01 for BTEX remediation must be voided if not owned as portable equipment by a consultant.
