VIOLATION NOTICE

On March 13, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Michigan Fuels Inc./Bill Saad Group located at 20700 Mack Avenue, Grosse Pointe Woods, Michigan. The purpose of this inspection was to determine compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of General Permit to Install (PTI) number 228-06.

During the inspection, staff observed the following:

Remediation	Gen Permit# 228-06 (Conditions SC. 1-8)	Failure to produce emission records

During this inspection, Michigan Fuels Inc./Bill Saad Group was unable to produce emission records. This is a violation of the recordkeeping and emission limitations specified in Special Condition number SC. 1-8 of General PTI number 228-06. The conditions of PTI number 228-06 require maintenance of records, which shall be made available for review upon request by the AQD staff. Enclosed is a copy of the General Permit for Soil Remediation Process.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by June 9, 2014, which coincides with 21 calendar days from the date of this letter. The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
