VIOLATION NOTICE

On August 9, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Norplas Industries, in particular the branch referred to as Magna Exteriors, located at 12200 Oakland Park Blvd, Highland Park, Michigan. The purpose of this inspection was to determine Norplas Industries compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the Michigan Air Pollution Control Rules.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Two Taylor TD1600 emergency generators rated at 2346 HP/1750 kW each	Rule 201	Two generators were installed at the facility and have been operated without a Permit to Install.

During this inspection, it was noted that Norplas Industries had installed and commenced operation of unpermitted equipment at this facility. The AQD staff advised Norplas Industries on August 9, 2024, that this is a violation of Rule 201 of the administrative rules promulgated under Act 451.

A program for compliance may include a completed PTI application for the emergency generators and the AQD acknowledges that Norplas Industries submitted a pending PTI application for these generators in June 2024.

Be advised that Rule 201 requires that a permit be obtained prior to installation, construction, operation, reconstruction, relocation, or alteration of any process or process equipment which may be a source of an air contaminant.

explanation of the cause and duration of the violation. And as noted above, Norplas Industries has submitted a PTI application to the AQD for the unpermitted generators. Therefore, the AQD considers this information and activity to be an adequate written response to this Violation Notice.

If Norplas Industries believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position by October 1, 2024 (which coincides with 21 calendar days from the date of this letter).
