**SECOND VIOLATION NOTICE**

On October 17, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted a complaint investigation of Great Lakes Trailer Washout (Facility), located at 8228 Neptune Drive, Kalamazoo, Michigan.

The purpose of the investigation was to determine the Facility's compliance with the requirements of the federal Clean Air Act; and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; Consent Order AQD Number 20-2016; and to investigate a recent complaint that the DEQ, AQD, received on October 17, 2016, regarding foul odors attributed to the Facility's operations.

On October 20, 2016, the AQD sent the Facility a Violation Notice citing violations discovered as a result of the investigation and requested your written response by November 10, 2016. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions the Facility will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our October 20, 2016, letter by November 29, 2016, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
