On January 18, 2018, I conducted a level-2 self-initiated **FY2018 inspection** of Tramar Industries ("Tramar") and Camau PICO ("Camau") located at:

1. **U-63-11-0334:** Camau PICO ("Camau"), 42850 W. 10 Mile Road, Novi, MI 48375-3204. Camau, FCA corporation, moved out over five years ago. Camau performed fabrication and assembly that involved use of paint spray booth.
2. **U-63-11-0334:** Tramar Industries ("Tramar"), 42850 W. 10 Mile Road, Novi, MI 48375-3204. Tramar moved into this building about four years ago. Tramar is a used / pre-owned CNC machines dealer / trader in NAFTA zone plus South America.

The inspections were conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

During the FY 2018 inspection, Mr. Marcos Damino (Phone: 248-426-5555; Fax: NA; Cell: 248-207-4204; E-mail: Marcos@TramarIndustries.com), Sr. Technician, assisted me.

The purpose of the inspections was to inspect a company that has not been inspected for nearly decade by MDEQ-AQD; AQD's (R. Loftus') most recent inspection of Camau PICO was on July 05, 2011.

Camau PICO)

Camau PICO moved out about five years ago. Camau performed fabrication and light assembly. Manufacturing required a paint spray booth, which is now used as a storage space by Tramar.

Tramar Industries

Tramar moved into this building about four years ago. Tramar is used / pre-owned (99%) CNC machines trader in NAFTA zone and South America. I found scores of used CNC machines

stored for repair, retrofit, and sale. Repair and retrofit is done by two electricians and one mechanic; total six employees including sales, inventory management, etc. No painting. No chemicals.

Paint spray booth

One paint spray booth (15 ft. W * 20 ft. D * 15 ft. H) is present. Tramar uses it as a storage space. Camau PICO used the booth in its manufacturing.

Conclusion

Tramar has no Clean Air Act regulated process as the booth is idled and will not be used. Camau PICO moved out.
