On June 16, 2015, I conducted a level 2 self-initiated inspection of Capital Stamping and Machine, Inc. (CSM) located at 30529 Andersen Court, Wixom, Michigan 48393-2877. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

Capital Stamping and Machine, Inc. (CSM) is in the business of supplying stamped automotive parts to Tier 2 & 3 suppliers to automakers; CSM also supplies directly to FCA US, LLC (Chrysler).

Six (6) CNC machines are present and metal removed from the parts is collected for recycling. Nine (9) stamping machines press the sheet metal to a desired shape and form. Water-based lubricants are used. No air pollution control device for particulate emissions is present. All emissions (all metals pieces or particles are heavy and are collected in bins) are released to in-plant environment.

No paint spray booth. No parts cleaner.
