STIPULATED ORDER FOR RESOLUTION OF DEFAULT JUDGMENT

At a session of said Court, held in the circuit courtrooms,
in the City of Lansing, County of Ingham, State of
Michigan, on the 28 day of October, 2024.

PRESENT: HON. JAMES S. JAMO
Circuit Court Judge

Plaintiff Michigan Department of Environment, Great Lakes, and Energy,
and Defendant Lemon Fresh Laundry & Dry Cleaning Centers, Inc. (Parties), by
and through their counsel, stipulate and agree pursuant to MCL 2.119(D) to a

proposed Stipulated Order detailing the requirements for satisfaction of the Default Judgment issued against Defendant on August 19, 2021, assessing a fine and costs.

The Parties agree that settling this action is in the public interest and that entry of this Stipulated Order, without further litigation, is the most appropriate means of satisfying the Default Judgment.

The Parties agree to be bound by the terms of this Stipulated Order, and state as follows:

1. A Default Judgment was issued in this case against Defendant on August 19, 2021, for \$42,970.20 in fines and \$150.00 in costs, for a total of \$43,120.20.
2. Defendant failed to pay the amount stated in the Default Judgment.
3. Upon completion of the requirements detailed in this Stipulated Order, the Default Judgment in this case is resolved.
4. If any and all of the terms in this Stipulated Order have not been satisfied by September 9, ²⁵~~2024~~, the Defendant shall additionally be subject to contempt of court penalties. jst
5. The terms of this Stipulated Order are as follows:
 - a. File with this Stipulated Order proof that Defendant ended and closed the business (Attachment A—Affidavit of Roger Lemmen), and show to EGLE a Certificate of Dissolution filed with the Michigan Department of Licensing and Regulatory Affairs;
 - b. Pay \$5,000 in total fines by September 9, ²⁵~~2024~~, in three separate checks payable to the "State of Michigan" and submitted as follows:

1. \$2,970.20 in past due air and licensing fees mailed to:

- c. Include with every check a copy of the Default Judgment and a note stating the Defendant is paying the fees listed in the attachment; and

6. If the terms of this Stipulation are not satisfied, Defendant is subject to the original default judgment and will be subject to further sanctions for contempt of court.

AFFIDAVIT OF ROGER LEMMEN


The undersigned, being first duly sworn, deposes and states as follows:

5. I have no intention of conducting business as, or through, Lemon Fresh in the future.


