VIOLATION NOTICE

On April 4, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Engel's Auto Body & Sales located at 2800 North Michigan Avenue, Saginaw, Michigan. The purpose of this inspection was to determine Engel's Auto Body & Sales' compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and to investigate a recent complaint which we received on April 3, 2017, regarding solvent odors attributed to painting operations.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
2-Paint Booths	R287c	No usage records. Missing filters and/or filters in need of repair.

RECORDKEEPING/REPORTING.

During this inspection, Engel's Auto Body & Sales was unable to produce material usage records.

This is a violation of the recordkeeping specified in R287(c). A copy of the above cited rule/regulation was left with Mr. Pacholke while staff was on site.

RULE 910: AIR CLEANING DEVICES

On April 4, 2017, the AQD staff observed operation of surface coating of cars while the dry filter control system was not operating in a manner consistent with good air pollution control practices for minimizing emissions.

This constitutes a violation of Act 451, Rule 910, which requires that an air-cleaning device shall be installed, maintained, and operated in a satisfactory manner and in accordance with the administrative rules and existing law.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by April 25, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Engel's Auto Body & Sales believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of Engel's Auto Body & Sales.
