SECOND VIOLATION NOTICE

On July 27 and August 2, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of the commercial facility located at 25245 Ford Rd., Dearborn. The purpose of this inspection was to determine Sams Welding's, DAR Architecture's and Baydoun Holdings, PLLC's, compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On August 3, 2017, the AQD sent the owner and operators a Violation Notice citing violations discovered as a result of the inspections and requested your written response by August 24, 2017. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions the companies will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our August 3, 2017 letter by September 21, 2017, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
